I treat and manage acute and chronic neck and lower back pain patients as well as opioid dependent patients. I use suboxone for opioid dependent patients primarily. In addition, I treat and manage post stroke patients, post joint replacement patients, multiple sclerosis patients, any neurologic illness causing impairment or disability requiring rehabilitation such as spinal cord or brain injured patients, sports related injuries and osteoarthritis that causes pain. I also perform electrodiagnostic (EMG/NCV) studies, cervical and lumbar epidurals, cervical and lumbar nerve blocks, cervical and lumbar radiofrequency ablation, cervical and lumbar facet blocks, lumbar discography, trigger point injections, prolotherapy, joint injections, Botox injections for spasticity associated with stroke/traumatic brain injured/spinal cord injured patients as well as for cervical dystonia.
